



CCAV Events Update


'We are better together'

This year's conference was themed 'we are better together', and each of the sessions was included to further explore the reasons why.

This year, 130 people across 33 cemeteries attend the conference, which was held in Ballarat at the Mercure Ballarat Hotel & Convention Centre.

The delegates enjoyed either a tour of Ballarat cemetery or tours of Linton, Smythesdale and Buninyong cemeteries and a welcome evening at the Hop Temple Brewery.

The program included a number of informative and topical speakers to connect guests to new ideas, new methods, solutions to existing challenges, and key contacts to support each cemetery and crematoria moving into 2023 and beyond. The second day of conference commenced with Wadawurrung elder and traditional owner Aunty Joy Oldaker providing a welcome to country in the Wadawurrung language.

Cr Des Hudson OAM, Mayor of the City of Ballarat, welcomed guests to the Conference and spoke of the importance of cemeteries as sites of memory as well as places for research.

He encouraged conference guests to get out and explore Ballarat and thanked the CCAV for their important work.

Mary-Anne Thomas, Minister for Health was unable to be with us, but sent a video thanking cemetery trusts for continuing their work with families, especially during the difficulties of the last two years. She also thanked the CCAV for hosting the conference.

A presentation to Rita Woolley from Eltham Cemetery who retired after 35 years' service, and our immediate past President Judith Voce who is also retiring from the sector, we would like to thank them for their significant services and wish them all the best in the future.















The day was full of presentations and information from our Platinum partners.

Key Note Speaker Paul Taylor gave an animated talk on how to become your best self through a range of holistic measures including simple nutrition, optimised exercise, routine, and positive self-talk. A key message was: "Nothing changes if nothing changes."

Sessions on Cyber Security, Vegetation Overlays and their impact, Social Media, Split sessions on Customer experience with cemetery management systems, users of Opus Xenta, Plot Box, Chronicle and Excel Spreadsheets, and The Public Records Office of Victoria shared the requirements of the management of cemetery public records and what happens when we no longer need the physical records.

Keynote speaker and Cultural Anthropologist Dr Hannah Gould challenged each table to pitch a project with the following parameters: You have been given \$500k and 3 years. How would you study "a good death" in Australia? Dr Gould works with the Death Tech Research team at University of Melbourne, and has been recently working with the Australian Death Studies Society.

And finally, stand-up comedian, author, radio and television presenter Cal Wilson provided some light entertainment - based on her shopping experience around the trade show.

Day Three continued the theme of Key Note speakers and industry partners

Ange Elson unpacked the meaning of reconciliation, and discussed the benefits of having a Reconciliation Action Plan (RAP) in place for inclusion and diversity. She also spoke about what it takes to be better than our ancestors, and the kinds of work that need to be done for true change to happen. A key message was "Find where the energy is."

Leah Slee led guests on a guided tour of the trade room to introduce conference sponsors and allow each business to showcase their products or services. Leah encouraged guests to enter competitions on offer and collect brochures and other promotional materials to review after the conference.

Senior Associate - Corporate from Lander & Rogers Kate McGurk provided an update on memorial permit applications and Trust requirements. She gave an overview of relevant definitions and discussed obligations that commonly arise in the management of memorials. She also outlined how Trusts could protect themselves in relation to claims from damaged memorials. A number of interesting questions arose from this presentation, indicating that this was a sensitive issue for many.


Annie De Jong gave a presentation on sustainability strategies that Ballarat Cemeteries had in place to be kinder to the environment. She discussed water management, the solar battery back-up system, the conversion of fuel-driven plant to electric, and investigations into green gas and new methods of water capture. She also talked about some of the challenges associated with going green, and encouraged those interested in making their cemeteries more sustainable to choose a project – any project – to kick off their journey toward a greener future.

Marita Ryan and Mandy McDonald offered their expertise in how to manage disagreement and conflict around a Trust or Board table, together they offered general advice on good governance, approaches to dealing with tricky situations that arise, and what a healthy Board or Trust should look like. Trusts were encouraged to participate in ongoing training, and to engage with the many free online resources available.

The final presentation of the conference was from keynote speaker and town planner and urban designer Jenny Donovan. Jenny shared information about inclusive design, the impact that the design of spaces can have on people's lives, and how cemeteries can be designed to more thoughtfully meet the needs of their communities.

Annie De Jong closed the conference by thanking sponsors and partners and the Committee of Management for their help and support

The atmosphere of the conference was positive, and levels of guest engagement were high. We are looking forward to reviewing guest feedback and continuing conversations inspired by conference topics.



Phoenix Celebrates 40 Years of Service to the Profession

In 2023, Phoenix celebrates 40 years of supplying quality cast bronze memorial plaques to the profession. During this time we have grown to become the largest 100% Australian Owned and Operated Foundry. We are extremely proud of this considering we are based in a small regional town with a population of approx 2500, similar to many small Victorian regional towns. Some key highlights of our journey are as follows:

- * 1982: Charlie Rudd and Henry Raymond were approached by a local funeral director to reopen a recently vacated Foundry. They agreed and after 12 months of research they cast the first plaque in 1983.
- * 1988: Phoenix had outgrown the original premises and relocated to our current location at Duke St, Uralla.
- * 1990's: Phoenix employed sales representatives to assist with further growth. Phoenix now has 3 sales reps being Kelly Mulcahy (South-West Australia), Patrick Whyte (North-East Australia) and Tom Genusso (North America).
- * **2001:** Phoenix had become a recognised brand throughout Australia and entered the export market with sales starting into the UK. This resulted in Phoenix producing all bronze components for the Australian War Memorial in London, located on Hyde Park corner that was opened by Her Majesty Queen Elizabeth II on **11** Nov. 2003.
 - * 2003: To help our customers with the ordering process, Phoenix developed our industry leading Design Order and Tracking System (DOTS). This ordering system allowed customers from around the world to deal with Phoenix in a seamless manner, opening many doors.
- * 2006: Further expansion into the International market occurred entering the North American market. Phoenix quickly established ourselves as a preferred supplier in Canada due to our quality, service and fast delivery times.





Original Phoenix FoundryNew Modern Premises


- * 2008: Our success both domestically and on the international market had Phoenix quickly outgrowing our premises.

 An expansion of the current site occurred to allow us to deal with the increased business.
 - * 2014: Phoenix expanded further with a new joint venture facility set up in Pittsburgh, USA, to service the North American side of business. Unfortunately the joint venture didn't prove to be successful with Phoenix not having enough control over our product and service levels, so we withdrew from the partnership in 2017.
 - * 2017: Phoenix made some additional extensions to our factory to further assist with production, adding an individual pouring shed and also extending our moulding and pattern making areas. These changes have helped to set Phoenix up for the future with a large amount of additional capacity gained.
- * 2020: Client DOTS became the next big step for Phoenix during the Covid pandemic. Client DOTS allows cemeteries to assign a Username and Password to family members who are then able to design memorials in the comfort of their own premises. Once approved the order is sent back to the cemetery who reviews and submits to Phoenix.

Phoenix is proud to be bucking the trend of many manufacturing companies in Australia. We thank our large customer base for their support over the past 40 years and we looking forward to assisting the profession further into the future.

Hip Hip Hooray! Dearly Plaques celebrates Ten Years!

Starting as a part time gig in 2013 Dearly Plaques & Memorials was created as a small start-up business testing and refining the interim marker for the cemetery industry. Ten years on we provide aluminium signage, markers and memorials to cemeteries across Australia, into New Zealand and recently to the US. Employing two casuals, including the odd family member – that'd be Zac, who is currently studying Occupational Therapy at Deakin University and Grace who is a local and recently graduated with a Bachelor of Archaeology.

Our product range started with the interim memorial, which today is still the biggest seller, with Cemeteries including this 'good customer service' gem within their interment packages for their families. We now have over 50 aluminium products with customised signage being developed all the time. These customised products come from conversations with operators and the challenges they have with current signage, memorialisation and cemetery equipment; they are looking for something affordable, something that will last and look modern and crisp for a long time.

Recently Dearly Plaques & Memorials have ventured into the recycled plastic space to look for and develop with an Australian company a replacement product for concrete memorial bases. Creating an alternative to concrete for the stand alone bases or 'desks' Dearly is currently manufacturing the first base from recycled plastic, to look like but be considerably lighter that the existing concrete products. The bases are made from kerbside waster or HDPE (High Density Polyethylene) and include food containers, shampoo and milk bottles. Watch this space for the first Victorian Cemetery to trial the lighter recycled plastic bases made from up to 170 used 2 litre milk bottles for each unit.

Thank you to the local cemeteries and the industry for utilising our products, communicating on new ideas and promoting Dearly Plaques & Memorials. We are looking forward to what the next Ten Years holds for us in growth, innovation and entrepreneurship.
